2. Approve Council's financial statements for April 2025. (see appendix 2)

381.5 Receive update of final plans relating to VE Day 80 (verbal update)

The working group are holding a final meeting to co-ordinate planning on 1st May 2025. Advance notice of the Road Closure have been displayed, this has also been advertised on the council's website and social media.

Council Resolved risk assessments prepared for the parade and lighting of the Beacon. Councillors were advised safety marshals will be required for the parade. It was resolved those present will assist.

382.6 Consider and review the disabled public toilet at Tinkers Green (see appendix 3)

Due to recent mischievous vandalism the toilet facility has been closed for over a week.

Following review with the Handyman he has kindly agreed the following on a trial basis:

- Daily locking and unlocking of the facility. Approx 6am to 6pm.
- Daily checking and cleaning, completed by the Handyman, hours worked to be claimed as overtime during this trial period.

Council were reminded when the Handyman takes annual leave the facility will either remain open and cover arranged or will have to be closed.

Council resolved to review this at each time of leave.

Council will review with the Handyman and Clerk after a couple months to see if the procedures are working to everyone's satisfaction.

The Clerk will list on a future agenda for full council review as required.

1. Application: 02034/25/FUL
Applicant: Mr J Gerrad
Proposal: planning permission – change of use, extension and alteration to existing agricultural outbuilding to form 6 no. residential properties, erection of a detached garage with the construction of parking areas on site of the existing outbuilding and barn which are to be demolished and the siting of bio tech drainage units.
Location: Faulkers Farm, Faulkers Lane, Burgh le Marsh PE24 5HW.

Following discussion, council gave a neutral view to this application, however, would question if the road access is adequate.

2. Application: 02077/25/FUL
Applicant: Mr I Ellis
Proposal: Planning permission – siting of 36 no. static caravans and the erection of 4no. lodges and associated works.
Location: St Micheals Park, Skegness Road, Burgh le Marsh PE24 5AA

Council noted the application and plans, following discussion all resolved support of the application.

3. Application: 00424/25/FUL
Applicant: Ms T Johnson
Proposal: Planning permission – extension and alterations to existing dwelling to provide additional living accommodation.
Location: 36 Holden Drive, Burgh le Marsh PE24 5LZ

Council noted the application and plans. Following discussion, objection to the application was resolved. The building is on the boundary and too close the neighbouring property. The plan is over intensified.
